

Relativity Certification Contest Rules

1. This contest (“Contest”) is sponsored by Relativity ODA LLC, a Delaware limited liability company with its principal address at 231 S. LaSalle Street, 20th Floor, Chicago, IL 60604 (“Relativity”). No purchase necessary to enter or win. Void in South Africa, Japan, Australia, Hong Kong, Singapore, Brazil, India, and UAE, or where otherwise prohibited or restricted by law. This contest is open to individuals who are employed by organizations that have a valid agreement to use the software known as RelativityOne during the term of the Contest.
2. The Contest will run from **June 2, 2026 through June 18, 2026** (the “Term”).
3. To enter the Contest, participants (“Participants”) must complete the **Relativity aiR for Review Specialist Job Task Analysis Survey** (“the Survey”) **sent via email on June 2, 2026**. Participants may also enter by sending their name and contact information, including country of residence, and written request to enter the Contest via email to certification@relativity.com. By participating in the Contest, you agree to be bound by these rules, Relativity’s [Certification FAQ](#), and the decisions of Relativity, which shall be final.
4. **Five (5) Participants will be randomly selected to win a prize.** Each winner will receive a **voucher** that may be used to register **for one (1) free Relativity Pro certification exam** (valued at \$50.00 USD) of the winner’s choice and for which the winner is qualified to sit, subject to exam availability (“Prize”).
5. Exams may be scheduled via the Relativity Community site at community.relativity.com in July 2026. Exams scheduled with a voucher must be **registered for or before December 31, 2026** (“Expiration Date”). Any Prize not redeemed before the Expiration Date will become null and void. Relativity will not provide any refund or alternate in the event of a missed or incomplete exam or expired Prize.
6. Winners will be notified via email by 11:59pm CEST on **June 23, 2026**. Vouchers will be distributed to winners by 11:59pm CEST on **July 15, 2026** or earlier.
7. A winner may choose to decline a Prize. Winners must respond according to the timeline outlined in the email and in this document to receive a Prize. Relativity will **not** publicly disclose any information about a winner who declines a Prize.
8. Odds of winning depend on the total number of Participants. **Winners may not substitute or transfer prizes.** Relativity reserves the right to substitute a Prize of equal or greater value in the event that a Prize is unavailable. Prizes are not redeemable for cash. All taxes on prizes are winners’ responsibility.
